We have reserved the Friday, December 7, 2018 matinee show at the Hartford Stage, Hartford to take the St. Paul student body and faculty to see the magic of Charles Dickens heartwarming classic, "A Christmas Carol."

Buses will leave St. Paul shortly after 9:00 am to arrive at the theatre before 10:00 am. The performance begins at 10:30 am. We will leave Hartford around 12:45 pm and return to Bristol by 1:30 pm. Given the timing of the trip, students will be asked to bring a brown bag luncheon on that day.

Cost for the show/bus is \$30 per student.
